



HUMANE TRAP LOAN AGREEMENT

This agreement is entered into between (NAME) _____

In consideration of the mutual promises in this Agreement, and other good and valuable consideration, you agree, intending to be legally bound by this Agreement as follows:

1. The Equipment. Save A Kitty Feral Cat Program, Inc. owns the following items (the equipment). The Cost to Replace the Equipment and the Security Deposit for the Equipment are as follows:

2. Equipment Loan. We are providing the Equipment to you for such time as we in our sole discretion decide is appropriate. You agree to promptly return the Equipment by hand delivery to our address within one week or whenever trapping session is completed, whichever is sooner. You may not give or transfer the Equipment to anyone other than to us and temporarily to the veterinarian treating the animal. The Equipment may only be used to provide humane assistance to cats. **We will not loan equipment to transport cats to the Humane Society under any circumstances.**

3. Safekeeping. You will keep the Equipment in a safe place and use reasonable care in operating and safeguarding it. You will not be financially responsible for ordinary wear and tear on the Equipment, nor the cost of repairs and maintenance due to ordinary wear and tear. **Damage or deterioration from prolonged rain or snow is NOT ordinary wear and tear.** If you lose the Equipment, refuse to return it, it is stolen, or it is damaged beyond ordinary wear and tear as a result of your negligence or misconduct, you will promptly pay us the Cost to Replace the Equipment.

4. Security Deposit. At the time you borrow the Equipment, you will pay the Security Deposit for the Equipment, if requested. The deposit will be refunded when you return the Equipment in accordance with paragraph two above.

5. No Unattended Traps and Cages. You will not leave traps or cages unattended outdoors, in order to protect the animals and the Equipment. All trapped cats will immediately be covered with a sheet/blanket to help them remain calm.

6. No Liability. We are not liable for any bodily injury, property damage, injury to any animals, injury caused by any animals, or any other losses or damages whatsoever, in connection with the use of the Equipment.

7. Entire Agreement; Binding Effect. This Agreement is the entire Agreement between you and **Save A Kitty Feral Cat Program, Inc.**, and supersedes any prior understandings between us with respect to the subject matter. No modification to this Agreement will be valid unless in writing duly signed by both parties. This Agreement is binding on you and our personal representatives.
